Connect Montana, Emily Reported

- High Speed internet for St. Regis (Pilot program) there is \$400,000 grant with the support of the St. Regis Resort Board of \$100,00 available for this program

- Blackfoot would be providing the connection
- This project has been tabled as Blackfoot want to be a partner. Hopefully, the grant will be submitted in June for the second round of funding.

• The competitive grants have been awarded. Alberton ranked 64<sup>th</sup> and St. Regis ranted 120<sup>th</sup>. At this time not sure if either project is going to be funded.

- Red Bull Timber Sale
  - The Federal Fish Wildlife & Parks are saying "no". Montana Fish Wildlife and Parks not accepting the Federal Decision. The Council of Environmental Quality located in the Whitehouse is the Council that is suggesting "No" on Red Bull. A FOYA is being requested to see what science is being used.

Idaho Forest Task Force

Jim will be working to get this task force back on tract as it is a shame that way IFG is treating the county and its former employees.
